## ORDER

WHEREAS - AND the applicant institution/trust/society filed writ petition (C) No. 385/13 in the Hon'ble Supreme Court of India against the said recognition order dated 27-May-13 issued by ERC, NCTE and the Hon'ble Supreme Court disposed of the writ petition with a direction that recognition granted by the NCTE to the institution will apply for the academic session 2013-2014.
