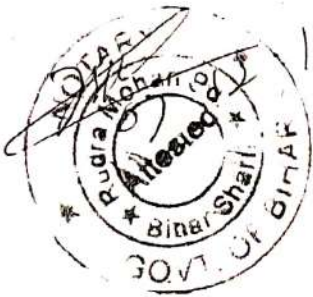


Rear view of the building



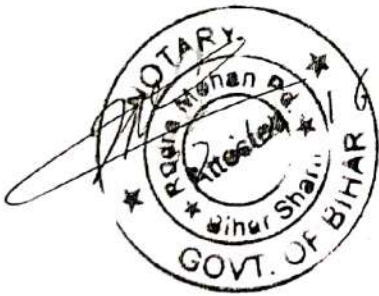
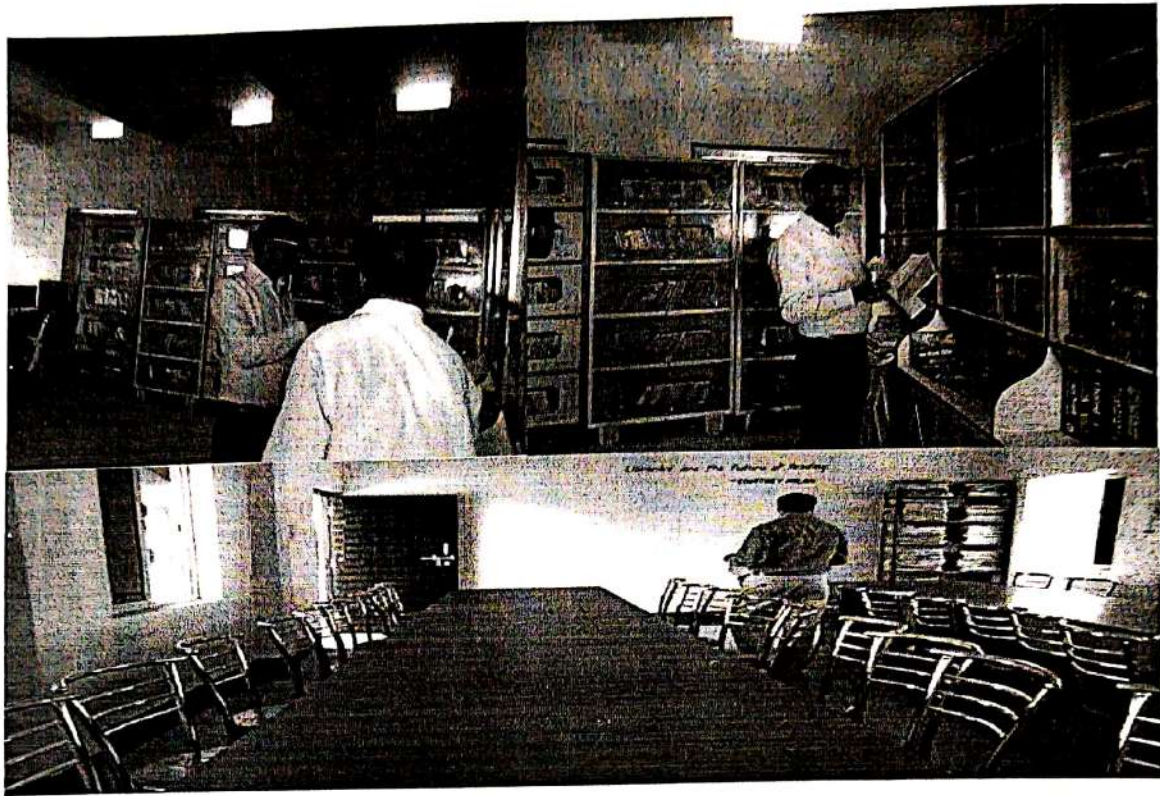
